Sessions will be allocated in accordance with our admissions policy so we cannot guarantee a place. If the sessions you request are fully booked we will contact you to discuss alternatives.

We will send you final confirmation of your booked sessions for the Autumn Term the week commencing **Monday 5<sup>th</sup> May 2018**, after which time the notice period will apply.

Children can attend the playgroup as soon as they turn 2. Sessions will be charged at £5.00 per hour. Many 2 year olds can receive 15 hours of free childcare/early learning a week from the term after they turn two. Eligibility criteria does apply. Please contact Conkers Children Centre for further information. Any hours over the 15 hours per week will be charged at £5.00 per hour. Children become eligible for Nursery Education Funding (NEF) from the term after they turn three. The current entitlement is for up to 15 hours (up to 30 hours for those eligible) of free childcare per week over a minimum of 38 weeks which can be split between two providers. Please visit <https://childcare-support.tax.service.gov.uk/par/app/applynow> to check eligibility. Funding can be used to cover morning, lunchtime and afternoon sessions. Any hours over the funded (NEF) hours per week will be charged at £5.00 per hour.

### **Notice Period**

The notice period for changing or reducing booked sessions is 7 weeks (term time i.e. not including holidays). If you need to make changes to your booking please contact me as soon as possible.
